



## Czech Federation of Majorette Sports

### Accreditation - photographer

*In accordance with the rules, regulations and competition rules, every person entering the area up to the protective zone of the marked competition area for performing competition sets in majorette sport must have permission from the organizer (Česká federace mažoretkového sportu, z.s = Czech Federation of Majorette Sport, registered association.).*

*Photographers are required to obtain accreditation, which is not automatically granted by the organizer. The number of accreditations issued is limited (for security, capacity, technical reasons, etc.) and their issuance is fully within the competence of the organizer of majorette sports.*

#### Accreditation conditions:

- 1) The organizer alone decides on the granting of photographer accreditation with the possibility of entering the area up to the protection zone.
- 2) The photographer or the organization that delegates the photographer applies for accreditation by filling out this form and sending it to the contact below.
- 3) The accredited photographer may enter the competition venue (sports hall) after the accreditation has been positively processed by the organizer, after reporting at the registration reception and **wearing a vest** that he/she will receive at the reception. Entry to the area is only possible in suitable, if possible sports shoes (heels, stilettos are prohibited) and in suitable clothing.
- 4) Prohibited areas are
  - the competition march route (25 m x 7 m) and its protective zones (2 m on each side of the marked route)
  - the competition stage area (12 m x 12 m) and its protective zones (2m on each side of the marked area)
  - the preparation, boarding and exit areas of the competitors, defined by the organizer
  - the judges' post the area in front of it and the defined area behind it (the accredited photographer must not obstruct the judges' view or disturb them when evaluating the competition sets)
- 5) Entry is also not permitted to non-competition areas, which are
  - marked changing rooms with accessories
  - areas designated for warm-up
- 6) Entry to the area during the ceremonies (opening, announcement of results) is not restricted, but must not disrupt their solemnity (anthems, speeches)
- 7) The use of flash light must not disrupt or endanger the competitor in performing the competition set. If he uses a tripod, he will agree on its placement with the local organizer.
- 8) The accredited photographer is obliged to respect the regulations and competition rules and is aware that he enters the area at his own risk. The organizer is not liable for any damage or harm caused to the accredited photographer during his movement around the competition area and in other available areas, nor for damage that his presence in the said areas, whether due to fault or not, has caused to third parties (e.g. damage to the camera due to falling equipment)

9) The accredited photographer is obliged to respect the instructions of the persons performing the organizing service and by signing the accreditation undertakes to cover any damage caused to the property or health of the participants of the majorette sport or the organizer.

10) The organizer of the majorette sport competitions reserves the right to withdraw the accreditation already granted, in cases it deems appropriate (especially in cases of violation of the accreditation conditions).

11) The accredited photographer agrees to deliver/send the photos to the organizer upon request and the organizer has the right to use the photos taken free of charge with the restriction that they are used only for his own promotion and the promotion of majorette sport events directly organized by the organizer and undertakes to provide them to the organizer upon the organizer's request, the minimum number is 30 different shots of the competition formations/ceremonies of the opening/announcement of results/competition end/per one competition day, the upper limit of the number of photos is unlimited.
